Patina: Annual Juried Artist Exhibit - featuring Pat Musick and Steve Halford

August 4th to September 8th, 2017

Submission Deadline: Saturday, July 22nd, 2017 by 3pm

Patina, a usually green film formed naturally on copper and bronze by long exposure and often valued aesthetically for its color, takes time and patience to acquire naturally. Artists must take the time, and utilize patience as they build the skills and develop their aesthetically beautiful art forms. This year's juried artists' exhibit honors the time you invest in creating your art. We encourage you to supply an artist statement with your artwork describing your process, or the philosophy you embrace to create your submissions for this exhibit. We will be featuring two Chaffee juried artists in exhibits within an exhibit.

Featured Exhibits: The Instant of it All, by Pat Musick and Fushiana Raku by Steve Halford

Entry Specifications:

- This exhibit is open to Juried Artist Members of the RAAA/Chaffee Art Center whose dues are current. If you have not paid 2017 dues, please do so.
- Each Artist may submit a maximum of 5 pieces of original artwork; due to wall space limitations only two pieces are guaranteed to be hung.
- All works must be ready for presentation. Two-dimensional work must have appropriate hardware and wiring installed and ready to hang. Artists will provide assistance installing sculpture over 25 pounds.
- **Identification labels, with artist's name, title of work, medium and price must be attached to the back of each two-dimensional piece and the bottom of each sculpture.**
- All artwork must be for sale. Sale proceeds will be split 60% to the artists and a 40% commission going to the Chaffee Art Center. There is a 20% referral fee on work shown in this exhibit and sold within two months of the exhibit close date (December 8th, 2017).
- Artwork submitted should not have been exhibited at the Chaffee in the past 3 years.
- Gift shop submissions may be brought at this time. Chaffee Art Center reserves the right to reject items deemed inappropriate or not up to quality standard. All items must come labeled with artist's name, title, medium, and price attached and a separate gift shop inventory sheet must be submitted at delivery.

Please complete and return this application form with image(s) of the art you plan to exhibit no later than **Saturday, July 22nd, 2017 by 3pm.** **Applicants annual membership dues must be up to date.**

A \$25 exhibit fee for up to five pieces of artwork will be due upon delivery of work. Make checks payable to the Chaffee Art Center. Please email if in lieu of an entry fee you would like either assist in hanging the show (four hours), preparing for the opening reception (four hours), or secure an exhibit sponsorship of \$500.00.
