## To Apply:

1. Complete the Entry Form.
2. **Submit 3 digital images representative of the work** you would like to submit. JPGs should be approximately 8X10 at 144ppi or 1152 pixels X 1449 pixels. Name each JPG with your first initial, last name and image number (example: *JSmith1.jpg*, *JSmith2.jpg*, *JSmith3.jpg*).

## Entry Specifications:

- This exhibit is open to **First Time and Former Chaffee Artists**.
- Each Artist may submit a **maximum of 3 pieces of original artwork**. Due to space limitations, not all pieces are guaranteed to be hung.
- All works must be ready for presentation. Two-dimensional work must be ready to hang with appropriate hardware and wiring installed.
- **Identification labels, with artist's name, title of work, medium and price must be attached to the back of each two-dimensional piece and the bottom of each sculpture.**
- All artwork must be for sale. Sale proceeds are split 60% to the artist and a 40% to the Chaffee Art Center. There is a 20% referral fee on work shown in this exhibit and sold within two months of the exhibit close date.

Please complete and return this application form and email images of the art you plan to exhibit no later than Friday, September 7, 2018. Each entry must be unique and original. Artists will be notified of their acceptance on or before September 15, 2018.

**A \$35 entry fee for up to 3 pieces of artwork** is due upon delivery of work. If you are accepted, you automatically become a member of the Chaffee for the remainder of 2018. If you are a current paid artist member, you do not have to pay the \$35 entry fee. Make checks payable to the Chaffee Art Center.
