



Application procedure for Artist Juried Membership

The Rutland Area Art Association d.b.a Chaffee Art Center invites artists to submit applications for juried artist membership. The Chaffee is a non-profit community arts organization with a mission to promote member artwork and educate the community. Members and non-members may apply. Once accepted as a juried artist member, a membership fee must be paid.

Benefits of Juried Artist Membership:

Featured Artists:

Juried artist members are invited to submit images to be juried as a featured artist. Featured artists are allotted 1 gallery within the building for a featured show. Once accepted as a featured artist, there is a \$100 exhibiting fee.

Artwork Sales:

All artwork must be for sale with a 40% commission going to the Rutland Area Art Association d.b.a. Chaffee Art Center.

Application Procedure:

A Committee will review submissions for juried membership. Applications may be submitted at any time. Requirements to apply:

- A jury form, which includes the sequence number, title, medium, size, and price of the pieces being submitted, as well as a completed Chaffee Membership Form. All may be found on our website, www.chaffeeartcenter.org.
- A current artist statement and resume.
- Ensure that your name, address, phone, and email address are included on each of your documents.
- Six high-quality images representing a cohesive body of work. Image quality deemed to be of non-professional standard will be disqualified from the jurying process.
- All files must be JPEG with the longest side 1920 pixels, and a maximum file size of 1.8 MB in RGB color space.
- Each image file is to include the title of the work, original size, and media used.

- Each image must be labeled with your name and sequence number near the top edge and the title, original size and medium near the bottom edge. Include indication of correct image orientation.

Artists will be notified of the Art Committee's decision. If accepted, membership needs to be paid to the Chaffee before any artwork is displayed. All Membership renewals due yearly on anniversary date.
